As required by article 11, b) n.2 of Regulation no. 05/2008 of the Portuguese Securities Commission, Sonaecom, SGPS, S.A. hereby informs that it has purchased, between 1 and 3 April 2009, through the Euronext Lisbon Stock Exchange, the following number of own shares, pursuant to the authorisations granted by shareholders at Sonaecom's Shareholders General Meetings held during 2008:

Sonaecom further informs that, as part of the obligations of the employee's Medium Term Incentive Plan, it has transferred to its employees and Directors, during March 2009, a total of 786.243 Sonaecom shares.

Consequently, as at 31 March 2008, Sonaecom was the holder of 6,110,954 own shares, representing approximately 1.67% of its share capital.

Following the additional purchases mentioned above, Sonaecom SGPS, S.A. is the holder, as at today, of 6,384,202 own shares, representing approximately 1.74% of its share capital.
